

Giving through the Nazarene General Treasurer

Lower Lights Ministries and Lower Lights Christian Health Center are both approved 10% Giving Specials through the Church of the Nazarene General Treasurer. This is a special benefit for Nazarene churches as it allows you to invest in the work of Lower Lights, and helps your church meet your annual church budgets.

There are two ways your church can receive “credit” through the General Treasurer’s office:

1. Your church can make financial gifts to our organizations through the “Church Remittance Form”;
2. Individuals from your church can also make financial gifts to our organizations and credit will go to your local church through the “Individual Remittance Form”

These forms are fairly self-explaining, however, we would like to provide you with some easy instructions to ensure timely receipt of funds and accurate credit to your local church.

Instructions for contributions from your church:

On the “Church Remittance Form”,

1. Print your church name and address on Item 1
 2. Enter the Assembly Year for which you would like to receive credit (generally this is the current year) on Item 2
 3. Indicate your gift designation:
 - Under Item 4 on the Form (10% Mission Specials), write the following depending on where you want your contribution to be used (you may split your contribution to go to each of our organizations) followed by the amount of your gift:
Lower Lights Christian Health Center (ACM 1693)
Lower Lights Ministries (ACM 1063)
- NOTE: It is critical that you include the “ACM” number to ensure proper designation.**
4. On Item 5, total your financial contribution, and include your check number on Item 6.
 5. Checks should be made payable to “General Treasurer” and sent to the address on the form.
 6. If possible, please contact our offices to inform us of your gift being sent.

Instructions for contributions from individuals:

On the “Individual Remittance Form”,

1. Print the individual’s name and address on Item 1
 2. Enter the Assembly Year for which you would like the church to receive credit (generally this is the current year) on Item 2
 3. Print the name and address of the church that will get credit on Item 3
 4. Indicate your gift designation:
 - Under Item 4 on the Form (Special Projects), write the following depending on where you want your contribution to be used (you may split your contribution to go to each of our organizations) followed by the amount of your gift:
Lower Lights Christian Health Center (ACM 1693)
Lower Lights Ministries (ACM 1063)
- NOTE: It is critical that you include the “ACM” number to ensure proper designation.**
5. On Item 5, total your financial contribution, and include your check number on Item 6.
 6. Checks should be made payable to “General Treasurer” and sent to the address on the form.
 7. If possible, please contact our offices to inform us of your gift being sent.
